

## Privacy Policy – Ebiquity Plc

Ebiquity Plc and its subsidiaries (inclusive of Faulkner Media Management, FirmDecisions and Stratigent LLC) (“Ebiquity” or “We”) are committed to protecting and respecting your privacy.

This policy sets out the basis on which any personal data we collect from you, or that you provide to us, will be processed by us. Please read the following carefully to understand our views and practices regarding your personal data and how we will treat it.

### How Ebiquity may collect and use personal information

We may use your personal information to fulfil your requests for information, either by filling in forms on our site [www.ebiquity.com](http://www.ebiquity.com), or corresponding with us by phone, email or otherwise. This includes information provided at the time of registering to use our site, subscribing to one of our services, posting material, requesting participation in conferences and events, evaluating any job applications or requesting any further services. We may also ask you for information when you enter a competition or promotion sponsored by Ebiquity, and when you report a problem with our site.

- If you contact us, we may keep a record of that correspondence.
- Ebiquity may also ask you to complete surveys that we use for research purposes and to create reports. No information about you as an individual respondent is made public from this.
- Details of your visit to our site (including, but not limited to – traffic data, location data as well as IP addresses and cookies as described below).

### Information we receive from other sources.

We may receive information about you if you use any of the other websites we operate or the other services we provide. [In this case we will have informed you when we collected that data that it may be shared internally and combined with data collected on this site.]

We are also working closely with third parties (including, for example, business partners, sub-contractors in technical, payment and delivery services, advertising networks, analytics providers, search information providers, credit reference agencies) and may receive information about you from them.

### IP Addresses

We may collect information about your computer, including, where available, your IP address and browser type, for system administration and to help diagnose problems with our server. This is statistical data about our users' browsing actions and patterns, and does not identify any individual.

### Cookies

A cookie is a piece of data that is placed in your browser, which it may then store on your system. It helps to distinguish you from other users of the website. Your browser can be set to alert you when you receive a

cookie, providing you with the opportunity to decline it, or you can turn them off all together. However by doing this you may hamper the user experience on certain websites.

### **Use of Your Information**

We may use information held about you to provide you with the information, products and services that you request or enquire about from Ebiquity, to notify you about changes to our services and to ensure the content from our site is presented in the most effective manner for you and your computer.

We may also use your information to provide you with information about other services we offer that we feel may interest you. If you do not want Ebiquity to use your data in this way, please tick the relevant box situated on the form on which we collect your data (the [order form OR subscription form]);

Information we collect about you may be used to to administer our site and for internal operations (including, without limitation, troubleshooting, data analysis, testing, research, statistical and survey purposes), to improve our site, to allow you to participate in interactive features of our service and as part of our efforts to keep our site safe and secure.

### **Disclosure of Your Information**

We may disclose your personal information to any member of our group, which means our subsidiaries, our ultimate holding company and its subsidiaries, as defined in section 1159 of the UK Companies Act 2006.

We may disclose your information to third parties, only if:

- In the event that we sell or buy any business or assets, in which case we may disclose your personal data to the perspective seller or buyer of such business or assets.
- If Ebiquity or substantially all of its assets are acquired by a third party, in which case personal data held by it about its customers will be one of the transferred assets.
- If we are under a duty to disclose or share your personal data in order to comply with any legal obligation, or in order to enforce or apply our [Terms of Use](#).

### **Links to Third Party Websites**

### **Where we store your Personal Data**

The data that we collect from you may be transferred to, and stored at, a destination outside the European Economic Area ("EEA"). Ebiquity will take all steps reasonably necessary to ensure that your data is treated securely and in accordance with this privacy policy.
